- 2.2 The Committee will meet under the chairmanship of the Chairman. In case the chairman is unable to attend the meeting he may authorise any member to preside over the meeting. Presence of at least 50% members would required to complete the qorum.

**4. Allowances of members:-**

Payment of TA/DA to the non-official members for attending the meetings will be made as admissible to class 1 officers.
