ORDER:

In accordance with section 34(1) of the Right of Children to Free and Compulsory Education Act, 2009, the Director of School Education has submitted a proposal for constitution of State Advisory Council to advise the State Government on implementation of the provisions of the Act in an effective manner.

2. The Lieutenant Governor, after careful examination of the proposal and in exercise of the powers conferred by sub-section (1) of section 34 of the Right of Children to Free and Compulsory Education Act, 2009 (Central Act 35 of 2009) is pleased to constitute the State Advisory Council for the Union Territory of Puducherry with the following composition, with immediate effect:-

3. The procedure for transaction of the business of the council shall be in accordance with sub-rule (5) of Rule 24 of the Right of Children to Free and Compulsory Education Rules, 2011.

4. The Non-Official Members shall hold office for a term of two years from the date on which he/she assumes office. He/she shall not be eligible for nomination for a second term. The other terms and conditions governing their office shall be as per sub-rule (6) of Rule 24 of the Right of Children to Free and Compulsory Education Rules, 2011.

5. The State Advisory Council shall discharge the functions enumerated under sub-rule (7) of rule 24 of the Right of Children to Free and Compulsory Education Rules 2011. The State Advisory Council may be also required to discharge any other functions as deemed fit by the Government for effective implementation of the provisions of the Right of Children to Free and Compulsory Education Act.

6. The State Advisory Council may invite/co-opt representatives from other departments/public as and when required. Such co-opted representatives/members are however not entitled to TA/DA for attending the meetings of the council.

7. The recommendations of the State Advisory Council are purely advisory in nature.
